Over the past several months the members of the TGMS Show Committee, the Board members and Pat and Rose have been working diligently to determine whether the 2021 Tucson Gem and Mineral Show® was going to occur. It meant double work for Pat and Rose because they had to prepare for putting on the Show at the same time there was the real possibility of not having the Show.

Multiple joint Zoom meetings took place with Show Committee and Board members attending, along with additional meetings that took place with the 50+ Show Promoters from throughout Tucson and city and county officials. In the end, you all know the difficult decision both the Show Committee members and the Board had to make. Having attended 58 Tucson Shows, exhibiting in most since 1971, and being involved with the Show Committee for 35 years, I, like Pat McClain and Peter Megaw, each with 42 years of involvement with the Society and the Show, along with the many other long-time members, had emotions that were tough to overcome. However, with the Show Committee's recommendation and the Board's decision to cancel the 2021 Show, this was definitely the right decision.

The ultimate decision was based on keeping our members, their families, our dealers, exhibitors and the public attending our Show safe. While many factors were considered, this was the most important one. Second, was the realization we could not put on the type of Show we are known for. Once we realized we could not have our school children visits, the Junior Ed area, the lectures, the micromount symposium, virtually none of the displays from museums and individuals, and many of our dealers, both domestic and international, the decision became a bit easier.

I want to thank Pat and Rose for all of their hard work during these trying times. I would like to thank our Show Committee and Board members for their diligence and willingness to attend Zoom meetings scheduled sometimes with just a day or two of notice. Also, I want to thank all of these members for keeping the information and decisions to themselves until we had conversations with others at the city, county, TCC and AGTA. Finally, I want to thank all of our members for being patient and understanding the difficulty of the decision.

We are already looking forward to the planning for the 2022 Show. It is the intention to move the themes for 2021, "The Show That Glows," celebrating the 50<sup>th</sup> anniversary of the Fluorescent Mineral Society, and the Apatite Supergroup to 2022, pending final approval by the Show Committee.

## TGMS Board Meeting - July 23, 2019

**Board Members Present:** Ellen Alexander, Diane Braswell, Mark Candee, Michael Hollonbeck, Mark Marikos, Les Presmyk, Marilyn Reynolds and Bill Shelton.

Call to Order: The Board Meeting was called to order by President Les Presmyk at 5:38 pm in the TGMS

meeting room.

Call for Orders of the Day: No changes were made to the agenda.

Minutes Approval: MOTION: To approve the March 20, 2019 Board Meeting Minutes as written. Seconded

and approved.

**President's Remarks:** We are here to make TGMS better. The President stated his philosophy is if something is working, leave it alone, but if not, fix it. He said that he wants the Board to make suggestions on the goals for 2020 (see suggested goals for 2020 below). He suggested that a staff member take the minutes so every Board Member is fully engaged in what is going on in the meeting. This was met with disapproval.

**Treasurer's Report:** Income was \$153,974.74 and expenses were \$8587.11.

**Old Business:** The Executive Manager reported that parking wheel stops will be ordered for the back edge of the parking lot for approximately \$400 and the parking lot needs to be sealed for which she will get bids. Neither item was in the budget. **MOTION:** To approve both expenditures using funds from a holding account. Seconded and approved.

#### **New Business:**

Internal Audit/Examination and Selecting the Committee: The President reported that six people were invited to participate. Out of the four who responded, Bruce Kaufman, Janette Simister and Kent Stauffer were appointed, with Kent to be chairman. The examination must be completed by August 5 so the books can go to the CPA.

<u>MOTION:</u> To approve Peter Megaw and Dick Gottfried as Show Co-Chairs. MOTION: To approve Peter Megaw and Dick Gottfried as Show Co-Chairs. Seconded and approved. The Guest/Special Exhibits Chair proposed getting new lighting for the display cases as new technology lights have true color. This would cost an estimated \$60,000 which would come from holding accounts and money from the Dallas Symposium. Up to \$5000 would be needed to test the new lights recommended. The President stated options would be to add a new row of lights to each case or buy all new lights. The Vice President stated that testing lights has already been done by the Exhibits Chair and others to pick the truest lights which are those sold by Tony Glecker. The recommendation was to set up three cases, ask vendors to provide the lights and Show Committee members to select their choice.

<u>Family Fun Day</u>: **MOTION:** To approve October 12<sup>th</sup> as the date. Seconded and approved. The Vice President will be in charge of the event.

Goals for FY 2020: Where do we want TGMS to be a year from now? Suggestions were: Increase number of young people; have a host at the beginning of meetings; continue and add more Community Outreach in schools; add a holding account for a building fund to buy or build a new TGMS building; don't change what's

working; more disclosure, transparency and accountability; encourage more use of the TGMS library; develop a questionnaire to hand out in meetings for answers to our questions; reach out to kids to add to their education after their Earth Sciences classes; encourage more members to volunteer; encourage members to stay after the program and snacks for the business meeting; encourage people to respect and acknowledge Pat and Rose for all they do for the Society; have mall shows and give out information and mineral specimens. Suggested goals will be revisited at the next meeting.

<u>Committees:</u> Scholarships – per Jessica Kapp at UA, the best time to give students the application for the TGMS scholarship is in the fall. **MOTION:** To start the application process now and send Jessica the information. Seconded and approved. The Executive Manager will send Board members information on how it was done last year. Everyone will read the applications submitted prior to the meeting and will bring in remarks and choices.

<u>By-Laws Revision:</u> Section I. Membership. D and E need to have TGMS lawyer define "congenial and in harmony."

<u>Board Meeting Schedule</u>: The following dates were agreed on: October 2, November 18, January 13 and March 30. All meetings to start at 6:00 pm.

Orchid Society: MOTION: To approve November schedule change. Motion withdrawn. MOTION: To give the Executive Manager authority to approve the schedule. Seconded and approved.

Call to Order: The Board Meeting was called to order by President Les Presmyk at 6:02 pm in the TGMS

meeting room.

Call for Orders of the Day: No changes were made to the agenda.

**Minutes Approval**: **MOTION**: To accept the October 29, 2019 Board Meeting Minutes as written. <u>Seconded</u> and approved.

**President's Remarks:** The President remarked that the holiday season was upon us and to enjoy the season. In January and February, we will be busy with the TGMS Show.

**Treasurer's Report:** The Treasurer reported on current income and expenses. The income and expenses are typical for this time period.

### **Old Business:**

**By-Laws Revisions**: The following sections of the By-Laws were reviewed:

Section III E: The Board determined that although the minutes are approved by an attorney, approval by an attorney does not need to be stated in the By-Laws. Section will remain as written.

Section IV H: The proposed expenditure limit of \$1,000.00 was reviewed and determined to be appropriate. Section will remain as written.

Section VII A 1 b: The Board reviewed the statement regarding the vote allotted to two persons acting as one chairperson. The statement will remain as written.

Section VII A 1 c iv: The statement was changed as follows: All Chairpersons who propose *changes to* budgets or expenditures exceeding \$5,000.00–10% of their budget shall prepare written documentation outlining a plan of action for adoption by the Show Committee.

Section VII B: The Ad Hoc Committees section will be deleted.

Section VII C: The statement was changed as follows: Appointive offices may be named by the President *on a fiscal year basis*, with the approval of the Board of Directors.

Section IX A: Grammatical changes were made to clarify monthly meeting dates.

Section XI: The Board considered a two-year term (elected annually) for the directors. The two-year terms would alternate so that only half the Board would be up for re-election each year. The Board determined that this is not a concern. The Section will remain as written.

When the revised By-Laws have been approved by the attorney, they will be published to the membership to be voted on in the next regular meeting. **MOTION:** To approve the amended By- Laws and the changes made by the Board. Seconded and approved.

<u>Naica Cave Project</u>: The project entity has not yet made a clear proposal that includes services and costs. The stage of the film production is not clear as well. Board Members propose that a TGMS Committee member review the film before a contract is signed. Board members are concerned about the timeline to complete the contract for the 2020 TGMS Show. **MOTION**: If the Naica project contract is not approved by the TGMS attorney and signed by the President by January 15<sup>th</sup>, the project will not be funded for the 2020 TGMS Show. In the event the contract is not signed, the project can be revisited for the 2021 TGMS Show. The motion was seconded and approved.

Renew Trademark: The Board was advised that the cost to renew the trademark would be \$2,800. **MOTION:** to approve \$2,800 to renew the trademark. Seconded and approved.

#### **New Business:**

<u>Scholarship Evaluation Process:</u> The President suggested that the process to evaluate applicants be revisited. The President and the Recording Secretary will develop a matrix to evaluate future applications. A timeline for the scholarship award needs to be established as well.

<u>Nominating Committee:</u> The past President will establish a nominating committee and results will be communicated to the Board.

Budget Schedule: Treasurer will have the budget drafted by the next Board meeting for discussion.

<u>Chinese Invitation:</u> An invitation was sent to Chenzhou City Government officials to attend the Tucson Gem and Mineral Show® for immigration clearance purposes.

<u>Conflict of Interest:</u> The attorney made changes to the Conflict of Interest Policy and Procedures to align with Arizona Law for Non-Profit entities. **MOTION**: To accept changes in the Conflict of Interest Policy as written by the attorney. Seconded and approved.

<u>Contract Signatures:</u> The President must sign all contracts for the TGMS Show. Contracts are updated annually by the attorneys. The Board may review these contracts in the spring.

#### Call to the Audience:

TGMS Show has spaces available for dealers. Refer to the website for additional information.

Next Board meeting is March 30<sup>th</sup>.

Donations of minerals, fossils and related material are needed for the Junior Education Area at the Show.

The Executive Manager continues to work with the Tucson Convention Center to accommodate TGMS needs as the TCC expands the addition of sporting events. Although Arizona Cine expenditures are high, the costs are reasonable for the services and facilities they provide.

<u>Call to Order</u>: The Board Meeting was called to order by President Les Presmyk at 2:13 p.m. via Zoom. A Zoom conference was held due to the current COVID-19 Pandemic.

**President's Remarks:** The President welcomed all attendees to the virtual meeting and hoped all was well with everyone. He commented on how COVID-19 was impacting all we do. He encouraged everyone to wear a mask and wash their hands.

**Minutes Approval**: **MOTION:** To accept the December 18, 2019 Board Meeting Minutes as written. Seconded and approved.

#### **Old Business:**

<u>TGMS Society Budget for 2020-2021:</u> The Board reviewed the proposed 2020-21 Fiscal Year Detailed Society Budget Draft. Items and changes were reviewed. The Board discussed building and property maintenance items that should be submitted for bids. **MOTION:** To approve the budget as submitted. Seconded and approved.

<u>2020/2021 Election of Officers and Directors:</u> Due to COVID-19, the Board determined that all current Board members would be nominated for their current positions, except for Diane Braswell who was nominated as a Director and Marilyn Reynolds as Membership Secretary. The Nominating Committee determined that the current Board members have the experience to move the Society forward in the uncertain future.

Due to COVID-19, if Legal Counsel advises as such, the Board discussed that the general membership be notified by email, regular mail or by phone, of the proposed 2020-2021 Budget and Slate of Officer nominations. The Board recommended a timeline of one week to mail the Budget and nominations to the membership, allow one week for comments, and one week for members to vote. Board discussed that a quorum could be 125 votes, the average number of voters in past meetings. **MOTION**: To approve the process of setting the two seven-day periods and getting final guidance from our attorney on how to proceed with getting the Budget and Slate of Officers voted on by the members, and what constitutes a quorum. Seconded and approved.

Board determined that the membership would be reminded to renew their 2020-2021 dues, (normally due by July 1<sup>st</sup>, 2020), and that the deadline should be extended to July 31, 2020. **MOTION**: Membership 2020-2021 dues will be due by July 31, 2020. Seconded and approved.

Members on the current roster will be eligible to vote, even if the timeline to vote is beyond the annual membership period. Members will be encouraged to vote electronically.

Orchid Society Lease: The Orchid Society has not held meetings in the building since April. The lease is due for renewal. The Board discussed the cleaning that would need to take place before and after meetings. It was determined that the safety of TGMS employees was paramount, and the lease would not be renewed at this time. **MOTION**: To postpone the Orchid Society Lease due to COVID-19. Seconded and approved.

<u>Approval of 2021 TGMS Show Co-Chairs – Peter Megaw & Dick Gottfried</u>: **MOTION**: To approve Peter Megaw and Dick Gottfried as the 2021 TGMS Show Co-Chairs. Seconded and approved.

<u>Approval of TGMS Employee Discretionary Time Off:</u> **MOTION**: To approve five days of Employee Discretionary Time Off for each employee to be used by the end of the calendar year. Second and approved.

<u>Summary Report on the 2020 TGMS Show and Naica Video:</u> The Show was successful from the standpoints of budgets, coupon usage, and staging the Naica Cave Presentation. Producing the 2021 TGMS Show will be reviewed in the fall, with consideration to COVID-19.

#### **New Business:**

<u>Future Topics:</u> Agenda for the next meeting may include finishing the review of the Bylaws, scenarios for producing the 2021 TGMS Show, approving building expenditures, and methods to engage members electronically during and after the COVID-19 Pandemic.

<u>Schedule Next Zoom Board Meetings:</u> The Board agreed to meet monthly, on the 3<sup>rd</sup> Friday of the month at 2:00 p.m. via Zoom. Future meetings will be July 17, August 21, September 18. October 16, November 20, and December 18.

Adjourn Meeting: Meeting was adjourned at 4:16 p.m.

I am sitting here, two days after the presidential election, and still don't know who will run our country for the next four years. These are certainly uncertain times -- there's a great oxymoron for you.

We do not deal well with uncertainty. Everything should be yes or no. Black or white. Wearing masks and social distancing are sure to keep us safe from the Coronavirus, say some experts while other experts tell us masks are not the answer. What gives? Certainly experts should know. What good are they if they don't?

What we don't realize is that scientists -- and doctors -- deal with uncertainty. They know that nothing is 100% and are comfortable with it. They state that there's a 90-95% chance that they are right. This is good enough for them to say that something is good enough to render a solid position. But, remember there's also a 5-10% chance that they are wrong. They aren't 100% certain, but close enough. Close enough is usually "close enough" for them. This is where the arguments start.

What am I leading up to here?

The Show Committee had a problem this year.

We apparently dodged the bullet with our 2020 Show (close enough). Covid-19 was not an international pandemic at that time (or so it seemed). Unbeknownst to us, President Trump had banned all travel from China, preventing some large-ticket buyers from attending all Tucson shows. But domestic travel was not as severely affected, nor was other international travel. We had a successful Show (as usual). We congratulated ourselves, and rightly so, never expecting the 2021 Show to be a problem. But this wasn't certain.

And then the pandemic hit. We were infected worldwide with a virus that we thought will kill all of us if we didn't shut everything down and stay at home. I remember that Sharon and I had reservations for our St. Patrick's day corned beef and cabbage dinner at 4:00 p.m. Good timing... because starting at 8:00 p.m. that evening, the Mayor shut down every restaurant in Tucson completely for the following two weeks.

Now with all the uncertainties, what was the Show Committee to do? Two alternatives:

Have the Show. Don't have the Show.

Before making a final decision. The Show Committee continued to plan for the 2021 Show as if it would occur, making all the usual decisions the Show Committee would have: the theme for the Show; the Show poster; advertisements; floor plans; etc. But now we had additional things to consider. Would it be safe to have the Show? How could we ensure that we didn't become a "super spreader" with people coming in from all over the world? We contacted the Pima County Health Department for guidance. They came up with several recommendations, that were major impacts on our decision.

We had meetings with city and county officials to discuss the options we would have, and met with other show venues throughout the city about their plans for continuing their shows next year.

After many weeks of discussion, The Show Committee made their decision, recommended to the Board of Directors that we do not have the 2021 Show but that we delay it until 2022. The Board approved our decision. In all the meetings that were held, everyone was given the opportunity to dissent, but no one did. It was unanimous that this was the only alternative.

So what does that mean for our Society in 2021? The Show is our greatest fundraiser, and we rely on it for funding our activities throughout the following year. Fortunately, according to our Treasurer, this is not our only source of income. We have some rainy day funds that could help eke us through 2021 without the proceeds of the 2021 Show.

Let me make this very clear. Financial considerations were only one part of our considerations. If we didn't get enough dealer booth revenues, or if we couldn't get enough of the public's admission revenues, the Show would end up costing <u>us</u> money. The funds we have to keep us going for the following year could be severely depleted.

This would be the least of our considerations because:

We are known internationally as an educational event. This is the chance for many in the field to make

contacts with their peers, and to meet other experts in the field. If we decided to put on the Show, it would be a sad travesty of our usual offerings. Major exhibitors and museums would not bring their fantastic displays because of travel bans and fear of infection. Junior Ed would be cancelled, and there would be no school visits. There would be no lectures as the attendance would be too severely restricted by Health Department rules.

The Health Department rules would also restrict the number of people allowed on the Show floor at any one time. This number would also count dealers and volunteers, not just the general public. I envision long lines waiting for someone to leave before someone can get in.

Education is our Show's forte. I'm afraid putting on the Show in 2021 would make it more like a Show's "fort"!

But look on the bright side! Those of us optimists know that there will be vaccines against the virus by the end of the year. First responders and health care workers will get the first doses. Then, in 2021 come the "old farts" like me (and several others on the Show Committee). By the middle of the year, the vaccines will be available for the general population, and by 2022, the crisis will have passed. Then we can have our 2021 Show in 2022. And the planning has already begun! Rest assured that we will have an even more fantastic Show in 2022 that will knock your socks off!
