### TGMS General Meeting — May 1, 2017

The General Meeting of the Tucson Gem and Mineral Society was called to order by President Mark Marikos at 7:30 p.m. Visitors and new members were welcomed to the meeting and asked to stand and introduce themselves.

**PROGRAM:** Michael Conway spoke on "The Fate of the Arizona Geological Survey" which traces its roots in 1887 and has been publishing since 1915. It has been booted out and defunded by the State and moved under the University of Arizona. On April 28, 2017 Governor Ducey signed State Bill 1415 which gives all Arizona Mining and Mineral Museum assets to the University, including the Polly Rosenbaum Building with 30,000 square feet (former home of the museum), over 21,000 mineral specimens worth approximately eight million dollars and 1400 mining artifacts worth one million dollars. Other assets are the volunteers and fifty thousand visitors annually. The new "Rebirth of Arizona Mining, Mineral and Natural Resources Education Museum in Phoenix" will emphasize sustainable natural resource use and will go from "look and listen" to "experience and engage." The museum needs more natural resources including forests, landscapes, ranching, agriculture and water. It hopes to become self-sustaining. It is working with other groups to share resources including the Patagonia Museum, Arizona Capitol Museum, Arizona Historical Society, South Mountain Environmental Education Center and Tohono O'odham.

**BREAK:** Many thanks to Cathie Logan who provided refreshments including crackers, cheese, meat, vegetables, deviled eggs, fruit and cookies.

The Board Meeting was called to order by Vice President Michael Hollonbeck at 6:56 p.m. in the TGMS conference area.

<u>Minutes Approval</u> of the August 11, 2016 Board Meeting: **MOTION:** To approve the minutes as written. Seconded and approved.

### Is it a Crystal or a Crystal Form?


Are you thinking about our 2018 Tucson Gem and Mineral Show®? It's less than six months away. But it's never too soon to start thinking about it. Our theme is "Crystals and Crystal forms," but what do we mean by that? A *crystal* is defined as a regular and repeating internal arrangement of atoms bounded outwardly by planes. Huh? Simply put, it's a geometric shape, the result of an arrangement of atoms of a chemical element or compound. So crystals of sulfur, S, a native element, may look like modified pyramids or even *pseudo-cubic*. While crystals of fluorite, a compound, CaF2, resemble cubes or 4-sided pyramids called octahedrons.

There are six basic crystal systems we

use to classify minerals – isometric or cubic, tetragonal, hexagonal, orthorhombic, monoclinic and triclinic. We'll take a closer look at each of these in the coming months leading up to 2018 Show.

Then there is the subject of crystal forms. To the mineralogist, a form, also called *habit*, is a descriptive word that brings to mind the shapes of clusters or aggregates of individual crystals. Some of these terms can be very colorful – acicular, arborescent, dendritic, rosette, stalactitic. Some azurite crystals may look blocky in appearance. A common habit for copper is arborescent. And




needle-like sprays of aurichalcite are described as acicular.


Maybe a good way to distinguish one from the other is to say a crystal is geometric while a crystal form is descriptive. Will the exhibits at the 2018 Show make this distinction? Maybe.

Each junior age exhibitor, regardless of which exhibitor class they enter, will receive a \$100 check from Dr. Rob Lavinsky of The Arkenstone. He wishes to help encourage young collectors to exhibit and compete and this is his way of honoring those adults who helped him when he was a junior-age collector. The high point score by a junior-age exhibitor will receive a \$500 check and the second high point score will receive a \$300 check, regardless of the exhibitor category.

Various applications are available for you to enter competitively. If you would like to have the forms, information or a competitive handbook sent to you, please contact our TGMS Office. Applications must be received no later than December 4, 2017. Due to increasing security concerns, ALL competitive entries, including those for the Special Trophies and Best of Theme competitions, shall require a signed Competitive Exhibitor Agreement. No Agreement, No Entry.

The Tucson Gem and Mineral Show ® theme for 2018 is "Crystals and Crystal Forms." Trophies will be awarded for the best specimen in each of five size categories and lapidary/jewelry in the Best of Theme competition. An individual is eligible to enter a specimen in each category. This competition is open to all individuals and entries will be accepted up to 6:00 p.m. on Wednesday, February 7, 2018 (Best of Species/Bideaux Trophy entries 4:00 p.m.).

The Show Committee awards five special trophies to honor those who have contributed to mineralogy and the collecting hobby. The Desautels Trophy is for the "Best Case of Minerals in the Show," with the emphasis on quality and aesthetics of the specimens. The Lidstrom Trophy is awarded to the best single specimen contained within a competitive exhibit. The Yedlin Trophy is awarded to the best case of Master micromounts. The Bideaux Trophy is awarded to the best single Arizona specimen entered in this competition. The Romero Trophy is awarded to the best Mexican specimen or case in the Show. Any case or specimen to be judged for these trophies, except the Romero, must have a signed Competitive Exhibitor Agreement submitted.
